## **Purpose of the Course**

To enable students to critically examine and evaluate ethical concepts and principles, and to motivate them to apply them in their various professions.

## **Course Objectives**

By the end of the course, students will:

1. Be able to critically analyze various speculative moral theories as bases of professional life, decision-making and practice.

2. Identify and evaluate major ethical concepts in professional ethics in the light of biblical ethical foundations.

3. Develop biblical principles and guidelines for professional ethical living and decision-making.

## **Course Content**

A. An introductory synopsis that addresses the need for ethics in our contemporary society in the light of:

- 1. The moral vacuum after the traditional African taboos are gone
- 2. Competing ideologies and philosophies that may seek to fill the moral vacuum and crowd out the genuine Christian philosophy of morality
- 3. The high stakes which are connected with authentic Christian witness in a world that seeks to know God
- B. A brief survey of traditional African world-view in contrast with other world-views that inform choice-making. This includes a brief examination of:
  - 1. Erosion of African traditional values
  - 2. The pull of the emerging culture's values of importance
  - 3. Selected moral theories
- C. A brief examination of biblical foundations for responsible Christian decisionmaking, working and relating to include:
  - 1. Significance of call to ministry
  - 2. The Covenant Motif in scripture
  - 3. Selected images that inform ministerial identity and function
- D. An inquiry into role expectations on the part of the minister by:
  - 1. The minister himself/herself
  - 2. The Church which is shaped by the minister

- 3. The general public to be witnessed to
- 4. The administrative unit which employs the minister
- E. Exploration of knotty problems and ethical issues that confront the Church and clergy in Africa today like the following:
  - 1. Counselling difficult clients
  - 2. Dealing with those who fear mystical powers and witchcraft
  - 3. "Sex in forbidden zones"
  - 4. Tribalism, ethnocentrism etc
  - 5. Ambition and Zebedee Syndrome
  - 6. Financial accountability and responsibility
  - 7. Academic freedom and accountability
  - 8. Symbolic powers of the professional/pastoral person
  - 9. Professional relations—peers, superiors/subordinates, opposite gender and employers.
  - 10. Professional duties and obligations
